 - Policies and procedures to address Fraud, Waste & Abuse;
 - Process for reporting suspected Fraud, Waste & Abuse to PACE Compliance;
 - Protections for persons who report suspected Fraud, Waste & Abuse
- 5. FDR has a system whereby suspected misconduct, violations, FWA and privacy/security incidents can be reported that ensures anonymity and protects against retaliation. The system ensures a process of investigation and corrective action planning.
- 6. FDR agrees to self-report to the CV PACE Compliance Officer any discovery of FWA, violation of HIPAA, PACE regulation 42 CFR Part 460, HITECH Act, or CMS regulation. - 7. FDR agrees to disclose conflicts of interest.
- 8. FDR agrees to disclose separation of staff members that have access credentials to CV PACE systems and computers.

- 10. FDR agrees to provide CV PACE with documentation supporting its attestation to any of the elements described within this document.
